## WDRB STREAMING BOX GIVEAWAY OFFICIAL RULES

- 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.
- 2. <u>Eligibility</u>. Subject to the additional restrictions below, the WDRB Streaming Box Sweepstakes ("Sweepstakes") is open to residents of the state of Kentucky and Indiana who are 18 years or older at the time of entry. When you see the Daily Code Word announcement, TEXT the Daily Word Code to 74574 by 11:59 p.m. EST each day to enter the drawing for a chance to win the daily prize (as set forth below).

The Station will announce thirteen (13) days of Code Words over the course of the Sweepstakes Period. The Station will announce a fresh Daily Code Word each day. <u>Limit</u>: one (1) entry per person, per phone number, per day.
